# **Chamber Hosts Community Conversations**

he Citrus County Chamber of Commerce recently hosted two pivotal community events to address the challenges and opportunities brought about by rapid growth and development in the area.

Affordable Housing Discussion: On June 12, the Chamber, in collaboration with Habitat for Humanity of Citrus County, organized a crucial meeting at the Crystal River Church of God -Citrus Springs Campus. The event, focused on the pressing need for affordable workforce housing, featured a keynote speech by Former Senator Jeff Brandes, a prominent figure in housing policy. His insightful address paved the way for a comprehensive panel discussion led by Ron Daly, Board Chairman of Habitat for Humanity of Citrus County.

Panelists delved into the current housing climate in Citrus County, offering valuable insights and discussing potential solutions. Citrus County Administrator Steve Howard closed the event with a call for collaborative efforts, a sentiment echoed by the large turnout, highlighting the community's dedication to finding sustainable housing solutions.

Managed Growth Town Hall: The following day, June 13, the Chamber held a town hall event titled "Charting Citrus County's Future: Embracing Managed Growth for Sustainable Progress" at the College of Central Florida Wilton Simpson Campus. This event aimed to address the rapid development and population growth in the county, focusing on sustainable and responsible management strategies.

Sheridan Morby, Senior Research Economist from the Florida Chamber Foundation, began the event with an enlightening presentation on the Florida Scorecard, covering local population growth, job needs, tax revenues, housing issues, and educational attainments.
