



## 2026 Scholarship Award Criteria Citrus County School System

The Business Women's Alliance of the Citrus County Chamber of Commerce supports education through its scholarship program. Only female students will be considered for this award.

This is a one-time, non-renewable scholarship **for up to \$1,000**, that can only be used for books, tuition, fees, or other education-related incidentals **at a Florida educational institution**. Checks will be made payable to the recipient and the Florida educational institution she will attend.

Completed applications with all required attachments must be emailed to [bwa@citruscountychamber.com](mailto:bwa@citruscountychamber.com) or completed online **by Friday, April 3, 2026**.

Below are scholarship application guidelines and evaluation criteria used in selecting the recipient(s). The application must be complete, submitted on time, and have all requested attachments to be considered.

**1. The applicant must:**

- Be a Citrus County resident and a graduating/graduated (or GED) student within Citrus County
- Have proof of being enrolled in Citrus County as a homeschool student (if a homeschooled applicant)
- Provide proof of acceptance for enrollment at an accredited university, college, or technical school **in Florida**
- Have a GPA of 2.5 or better [non-GED students]

**2. Include a clearly written or typed 300-word essay that includes the following:**

- A brief autobiographical statement.
- Why do you want to further your education?
- Why do you choose to pursue your area of interest?
- Why you should receive this scholarship award.
- A summary of activities, honors, clubs, hobbies, work experience, and community involvement [be specific about your role in community service projects].
- Any other information that you feel is important for the Selection Committee in deciding if you would be a good investment for the Business Women's Alliance and the community.

**3. Include a short video clip (30 seconds or less) or written statement that includes:**

- What you would like the BWA to say about you if you are chosen to receive this award
